## Student Parking Regulations and Application

Limited automobile parking for students (approx. 500 spaces) is provided as a convenience. Parking is a privilege, not a right. As our enrollment grows, there is an increasing competition for a fixed number of parking spaces. For that reason, MVHS will only issue parking permits to upper classmen as we grow. Spaces cannot be held for late arrival students. Students driving to school will only be allowed to ride the bus in emergency situations.

School District 204 provides bus transportation for all students who meet the state distance guidelines.

1. A parking permit may **NOT** be transferred to another student, including siblings – **to do so is to use school property without permission, and subject to discipline sanctions for misuse / theft of school property.**
2. Parking permits will be decal- type and must be **permanently affixed and displayed** in the driver-side rear window. They may not be taped on or laminated then affixed to the window. The sticker itself must be affixed to the window
3. **Each student must show an actual VALID driver's license, current proof of insurance, the completed attached forms, and check or cash** to pick up their sticker. MVHS is not responsible for the automobile or any of its contents.
4. The privilege to park will be suspended or revoked for inappropriate conduct, such as reckless driving, loitering in the parking lot, leaving campus, excessive tardies to school or other serious offenses relating to use of the vehicle. If a student loses his parking privilege, the school is NOT required to refund the \$150.00.
5. A permit **may be revoked for the semester** if the driver cuts a class and enters the vehicle, or uses it to leave school.
6. Smoking is also prohibited in vehicles at school. Students are not to smoke in or around the vehicle after it enters our campus.
7. Students must heed "no parking" areas. These are posted or marked and include fire lanes, the faculty areas, visitor parking, and special permit parking. **Cars parked with or without a permit, either outside designated student spaces, or illegally, are subject to immediate towing.**
8. Students will obey all traffic laws as if they were driving on a public roadway. Cars must not be a disruption to the educational process, ie. loud stereos, etc. Failure to comply may result in revocation of parking permits.
9. The parking permit fee is \$150.00 for the school year. Students will need a permit to park starting the first day of school. Student and parent signatures on the application indicate acceptance of these regulations. Upper classmen **ONLY** may purchase a daily parking pass for \$5.00 per day if they choose not to purchase a permanent sticker at \$150.00.
10. We may issue temporary permits to accommodate emergencies or special situations. It is the **student's responsibility** to request a temporary permit in advance and to explain fully the justification to the dean. **ONLY STUDENTS WHO CURRENTLY HOLD A PARKING PERMIT WILL BE ALLOWED TO OBTAIN A TEMPORARY PARKING PERMIT for Free.** In addition, consideration will be given to those with medical concerns.
11. Students must purchase a new sticker for \$10.00 if they wish to register a new car. Students may only register ONE car. The original sticker must be removed from the original car registered and brought to the office in any condition you can get it off the vehicle before a replacement will be issued. Scrape this off the car prior to trade or sale.
12. Cars must pull into the space "nose-first". Cars are not permitted to back into a parking space, or occupy more than one parking space.
13. MVHS is a self-park facility. Any car at this facility is parked at the owner's risk. The owner alone is responsible for parking and locking his/her car. MVHS is not responsible, nor assumes any liability for any damage caused by fire, theft, casualty or any other cause whatsoever with respect to any car or its contents parked at MVHS.
14. ALL vehicles will be required to comply with the above mentioned rules / regulations at all times. **FAILURE TO COMPLY WITH THE AFOREMENTIONED RULES WILL RESULT IN IMMEDIATE TOWING FROM MVHS PROPERTY. METEA VALLEY RESERVES THE RIGHT TO TOW ANY ILLEGALLY PARKED VEHICLE FROM ITS PROPERTY WITHOUT NOTIFYING THE DRIVER OR OWNER.**
